High impact grants are extended each June to local, worthy nonprofits selected by our members. Impact Austin solicits proposals for programs or projects in five focus areas: culture, education, environment, family, and health and wellness. These grants are funded by combining annual donations from members. Current membership requirements are simply to be female and to donate \$1,250 each year, with \$1,000 going to grant recipients, and \$250 going to supporting Impact Austin operations. Beyond this, each member can be as engaged or involved as she chooses. In June of 2014, Impact Austin gave grants of \$100,000 each to five nonprofits within the local community.

Girls Giving Grants teaches young women leadership and the art and importance of giving.
